Terms & Conditions of Lunar New Year Online Discount, Gift & Lucky Draw ("Promotion")

 - a) you must apply for an insurance policy listed in the table in section 4 online at msig.com.sg during the Promotional Period which is accepted by MSIG and premium fully paid; and
