

AIG x SingSaver Car Insurance Promotion for February – Terms and Conditions

1. Eligibility

- 1.1. The **AIG x SingSaver Car Insurance February Promotion** (the "Promotion") is organised by AIG Asia Pacific Insurance Pte. Ltd. ("AIG"). It will be held from 2 February 2024 to 29 February 2024, both dates inclusive (the "Promotion Period"). For the avoidance of doubt, SingSaver is not an organiser of the Promotion, nor is it involved in the supply of the gifts.
- 1.2. The Promotion will be administered and run by AIG and is only open to Singapore residents only ("Eligible Individuals").
- 1.3. Eligible Individuals who successfully purchase a valid AIG Car Insurance Collision Only policy or AIG Car Insurance Complete policy for a vehicle that has not been insured under any AIG Auto policy in the last 12 months during the Promotion Period (each an "Eligible Policy" and collectively "Eligible Policies") provided (a) the purchase is made via the link at www.singsaver.com.sg/insurance/car-insurance; and (b) the code "030309" is keyed into the "Producer Code" field on the online purchase path; (c) the promo code "AIGSS5" is keyed into the "Promo Code" field in the user journey; and (d) the Eligible Policy is not subsequently cancelled, will be entitled to:
 - i. the Discount provided the Eligible Individual has a maximum of one (1) at fault claim experience, with total claims amount not exceeding \$\$40,000, in the past three years; and/or
 - ii. the Gift when net premium payable for the Eligible Policy after the Discount (if any) is S\$600 and above; and/or
 - iii. the Additional Gift provided the Eligible Individuals (I) download the AIG On the Go mobile application from Apple or GooglePlay app stores or from www.aig.sg/otg; and (II) register for a new AIG On the Go account using the same vehicle registration number and email address which was provided to AIG at the point of purchase of the Eligible Policy during the Promotion Period. For the avoidance of doubt, the Eligible Individual will only be entitled to the Additional Gift if the vehicle registration number and email address used to register the new AIG On the Go account, had not previously been used to register for an AIG On the Go account.

The details of the Discount, Gift, and Additional Gift are summarised in Table 1 below:

- 1.4. At the time the Gift and/or the Additional Gift is emailed to the Eligible Individual, the Eligible Policy must be valid. In addition, to be eligible for Additional Gift:
 - i. The AIG On the Go mobile application must not have been deleted; and
 - ii. The AIG On the Go account must not have been deleted.
- 1.5. More details on the redemption of the Gift and/or Additional Gift are set out in Section 2 below.
- 1.6. This Promotion is not valid in conjunction with any other promotions, discounts or offers offered by either SingSaver or AIG, unless otherwise stated.
- 1.7. Employees of SingSaver and AIG and their immediate family members are eligible to participate in the Promotion provided that the policy is purchased without the use of any staff discount(s).



2. Notification and Redemption of Gift and Additional Gift

- 2.1. AIG will send an email or SMS for the redemption of the Gift and/or Additional Gift ("Redemption Notification") within six to eight weeks from the end of the Promotion Period to the electronic mailing address or mobile phone number of the Eligible Individual which was provided to AIG at the point of purchase or renewal of the policy.
- 2.2. The Gift and the Additional Gift are subject to the terms and conditions of the issuer, and AIG will not accept any liability in relation thereto.
- 2.3. AIG shall not be liable if the delivery of the Redemption Notification to the relevant Eligible Individual is unsuccessful. AIG reserves the right to deal with any Gift and/or Additional Gift returned to it for any reason in any manner it deems fit.
- 2.4. Once the Redemption Notification(s) is/are sent, Eligible Individuals will not be allowed to cancel their policies.
- 2.5. The Gift and/or the Additional Gift is not transferable or exchangeable for cash, credit or kind. AIG reserves the right to replace the Gift and/or the Additional Gift with other items of similar value without prior notice.

3. General Conditions

- 3.1. By participating in the Promotion, you agree to be bound by these terms and conditions ("T&Cs").
- 3.2. AIG reserves the sole and absolute right to do the following at any time:
 - disqualify any person from his/her participation in the Promotion for any reason whatsoever;
 and/or
 - ii. disqualify any person from receiving the Gift and/or Additional Gift under the Promotion for any reason whatsoever; and/or
 - iii. claw-back the Discount awarded pursuant to this Promotion for any reason whatsoever.
- 3.3. Without prejudice to the generality of clause 3.2 above, non-compliance with these T&Cs and/or the breach of any other requirements communicated by AIG to the Eligible Individuals may, at AIG's sole and absolute discretion, result in the immediate disqualification of said person from participating in the Promotion.



- 3.4. AIG's decision on all matters relating to the Promotion will be at its sole and absolute discretion and will be final and binding on all parties, and no correspondence shall be entered into in relation to the same.
- 3.5. AIG reserves the right to extend or terminate the Promotion, and to vary, delete or add to any of these T&Cs at any time without notice, and at its sole and absolute discretion.
- 3.6. By participating in this Promotion, it is agreed that any information collected or held by AIG (whether contained in the application form or otherwise obtained) may be processed, used and disclosed by AIG, its associated individuals/companies and/or any independent third parties, to carry out the implementation and administration of the Promotion. Policyholders may opt-out of participating in the Promotion via the link here.
- 3.7. AIG shall not be liable in any manner for any claims, losses, damages or expenses arising out of, or relating to the Promotion or the use of the Gift and/or Additional Gift. For the avoidance of doubt, AIG is not the supplier of the products and/or services redeemed/purchased using the Gift and/or Additional Gift and will not accept any liability in relation thereto.
- 3.8. AIG assumes no responsibility for incomplete, lost, late, damaged, illegible, misdirected forms and/or other forms of communication, which may result in any policy not being purchased during the Promotion Period.
- 3.9. These T&Cs shall be governed by and construed in accordance with the laws of Singapore. The Courts of Singapore shall have exclusive jurisdiction over any disputes arising from this Promotion and these T&Cs, including the validity and enforceability thereof.
- 3.10. In the event of any inconsistency between these T&Cs and any promotional materials relating to the Promotion, these T&Cs shall prevail.
- 3.11. AIG Car Insurance Collision Only and AIG Car Insurance Complete are protected under the Policy Owners' Protection Scheme which is administered by the Singapore Deposit Insurance Corporation ("SDIC"). Coverage for these policies is automatic and no further action is required from you.
